

## CONDITIONS OF CARTAGE

### 1. LIABILITY FOR LOSS OR DAMAGE\*

In the absence of special arrangements in writing all goods are carried at "Limited Carrier's Risk" as defined in the Carriage of Goods Act, 1979. No liability is accepted for damages consequential upon loss of or damage to goods. No claim will be accepted if delivery docket is not endorsed at time of delivery. Goods must be checked on delivery. Dockets signed subject to inspection will be deemed to have been received in good order. A carrier's liability is limited to a maximum value on each package. Unless goods are adequately packed no claim will be recognised. The "Owner's Risk" clause on the invoice face need not be completed in the event of this Company holding a blanket authority in this regard.

### 2. DECLARATION OF CUBIC VOLUME

This is required on all consignments and if not declared will be estimated by our staff. Our Company reserves the right to charge freight by weight, measurement or value and may at any time re-weigh, re-value or re-measure and charge proportional additional freight if considered applicable.

### 3. FREIGHT FORWARD ITEMS

- (a) Freight charges may be made payable by the Consignee on the understanding that should they fail to pay the Consignor will make prompt settlement in full.
- (b) Any cost incurred by United Movers Ltd in the collection of any moneys not collected on delivery is payable by the party accepting freight charges.

### 4. INSURANCE

Insurance will not be arranged by our Company except with the express instructions in writing of the Consignor and then only at his expense and on lodgment of a declaration as to the value prior to collection.

### 5. DELIVERY

Should the Consignee of the goods described hereon not be in attendance at the address given during normal trading hours when delivery is attempted, an additional charge may be made at ruling rates for each call until delivery is accomplished.

### 6. CONCEALED DAMAGE

No claims will be accepted where damage has not been apparent at time of delivery and the note endorsed.

### 7. GLASS/MARBLE

Glass/marble is carried at owner's risk and no claim will be accepted in case of breakages, unless said items are crated for insurance purposes, and cover arranged.

### 8. CARTONS

Cartons are carried at owner's risk and no claim will be accepted in the event of breakages.

### 9. SPECIAL INSTRUCTIONS

No liability will be accepted for failure to meet special requests/deadlines if these are not stated in writing in the box provided on the front of this waybill.

**\*Limited Carrier's Risk does not cover Household Furniture Removals or Second-hand Furniture in transit. These must be covered separately on an individual basis. (Charges are available on request.)**

**United Movers Ltd shall be entitled to charge interest on overdue balances at the rate of 2.5% per month, plus any costs related to the management and collection of these accounts, including our internal costs and any fees charged by external agencies.**

**Any party contracting cartage services in so doing consents to the passing of information to credit agencies should they fail to meet their financial commitment.**
